**Liability**

Gupton Pet Care Center--Gupton PCC (official corporate name: Gupton's Pets & Supplies, Inc.) and their owners, employees, and agents shall not be liable for any damages to the pet(s) arising out of or from the boarding or grooming of the pet(s), or that may accrue from any cause in connection with boarding or grooming including loss by fire, theft, running away, death, or injury during the terms of this agreement, whether the pet(s) is on the premises of Gupton PCC or not, except where the loss is caused by gross negligence of Gupton PCC, or its owners, employees, or agents. Pet owner shall be solely responsible for all of the acts of the pet(s) at any time during the terms of this agreement, and in no case shall Gupton PCC be liable for the pet(s)'s acts and behavior other than for the exercise of gross negligence on the part of Gupton PCC in the boarding/grooming and keeping of the pet(s).

Pet owner shall indemnify Gupton PCC from and against any and all damages sustained or suffered by reason of the boarding or grooming of the prt(s) for any claims or injuries arising out of the boarding or grooming of the pet(s) except where the injury is caused by the gross negligence of Gupton PCC, its owners, employees, or agents

**Personal Belongings**

Pet owner agrees that Gupton PCC does not assume and shall not be held responsible for the loss and/or destruction of personal belongings left with the pet(s) while boarding or grooming including but not limited to bedding, toys, dishes, collars, tags, leashes, clothing, and food

**Complimentary Baths**

Pet owner agrees that complimentary bathes are given at the discretion of Gupton PCC staff and are not a required service covered under the boarding fees. Absolutely no bathing is available Sundays. Complimentary baths for small dogs are done no sooner than after a 3 night stay and generally the day before scheduled pick-up. Complimentary baths for medium to large dogs are done no sooner than after a 7 night stay and generally the day before pick-up. If your dog's bath is scheduled for pick-up day, it will not be completed before 4pm.

**Medical Conditions**

Pet owner agrees that Gupton PCC will not be held responsible for aggravation of any pre-existing medical conditions, including but not limited to heart disease, arthritis, obesity, infections and any other conditions that might be discovered by examination.

Pet owner agrees to provide written instructions for the treatment of an ailing pet (very old or with major health concerns) that passes while under the care of Gupton PCC. This includes but is not limited to treatment of the remains and the timing of contact of the owner to report the passing.

### **Medical Condition/Special Feeding**

Pet owner agrees to provide explicit written instructions for any and all medication pet(s) are taking including but not limited to the name, dosing, and the condition that requires medication.

Pet owner agrees to provide explicit written instructions for all foods provided by pet owner for use during boarding. Pet owner agrees that Gupton PCC will be allowed to offer other foods if pet is not eating food provided by owner. If no food is provided, Gupton PCC will provide food at no additional cost.

### **Illness/Injury/Death**

Pet owner agrees that (his/her) pet may change sleeping, eating, drinking, and activity level for several days after boarding due to the change in daily routine. Pet owner agrees not to hold Gupton PCC liable for any illness or ailment that may affect pet(s) if pet(s) become(s) ill during or after its visit. Pet owner agrees to indemnify and hold Gupton PCC harmless for any costs, damages, claims, or expenses arising there from.

Animals in a group situation, such as boarding, grooming, dog parks, training, etc. are exposed to common illnesses, similar to that of humans when they congregate together. Pet owner agrees to assume the risks and hazards that may be expected to arise from interaction with other animals.

In case of illness or injury, pet owner gives consent for the staff of Gupton PCC to administer first aid. If the severity of the illness or injury require veterinary care, pet owner shall be notified as soon as possible at the phone numbers on file or at the emergency phone number. If Gupton PCC is unable to reach owner or if owner does not immediately inform Gupton's regarding measures to be taken, or if the animal's health requires emergency action, pet owner grants Gupton PCC the right to send pet to the Veterinary clinic of Gupton's choice to treat said injury or illness. Pet owner consents for the attending vet to prescribe, treat, or operate on pet(s) while they are being boarded or groomed at Gupton PCC. Attending vet may send pet(s) to the emergency clinic after hours for intensive care, monitoring, and/or treatment at his/her discretion, and any expenses incurred in conjunction with such care is pet owner's responsibility and shall be promptly paid by pet owner.
